



## **Jackson \$aves -2023 Kindergarten Round Up Official Sweepstakes Rules and Regulations**

Valid email address is required. Alternate entries may be mailed on a plain 3.5"x5.5" postcard. The entry must include name, age, complete address, city, state, zip, day and evening phone numbers and email address. Mail your postcard to: TRUE Community Credit Union, Attn: Jackson \$aves -2023 Kindergarten Round Up, 1100 Clinton Road, Jackson, MI 49202. Entries are limited to one entry per household.. If no entrants submit a proper entry, no prize will be awarded. All entries must be received by Jackson \$aves no later than May 30, 2023, at 5:00 pm Eastern Standard Time to be considered for entry into the sweepstakes. One entry per household.
